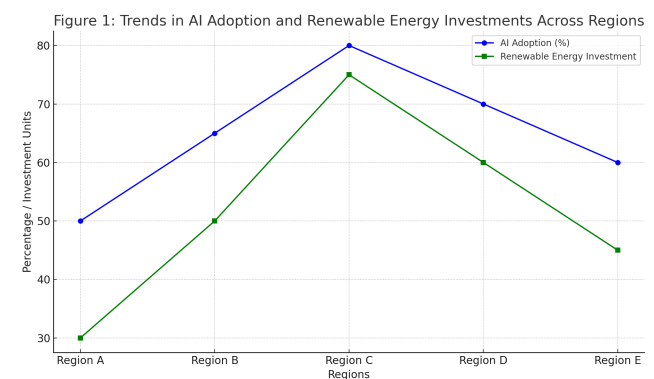


Figure 1. Example figure demonstrating image placement and caption formatting.

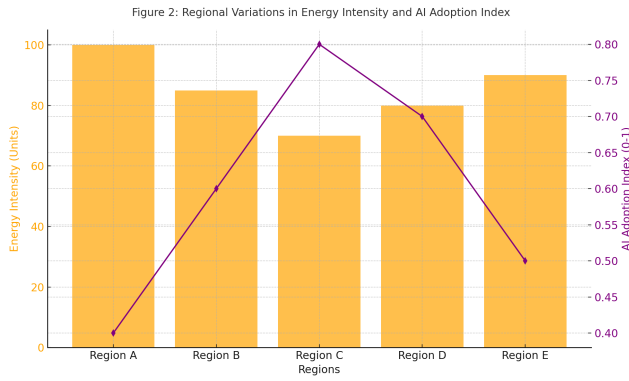


Figure 2. Example figure demonstrating a second illustration within the layout.
