This template is provided to help authors prepare their manuscripts for submission to the OSCM Journal. All manuscripts must be submitted through the OSCM Journal's online submission system, which will then be reviewed by the OSCM Journal's editorial team. The OSCM Journal is published four times a year. An example of active citation is provided in the following sentence. Pujawan (2016) describes how the ten-year anniversary of the OSCM Journal was celebrated in 2015 with a special issue on the future of OSCM. The special issue included 12 articles that were published in the OSCM Journal. One of the main topics of the special issue was the future of OSCM research. The special issue also included articles on the future of OSCM education, the future of OSCM practice, and the future of OSCM journals (Pujawan, 2016). The previous sentence exemplifies the use of a passive citation. References with two authors should be cited with both surnames, e.g., (Devi & Ganguly, 2021). References with three or more authors should be cited with the first author followed by *et al.* (in italics), e.g., (Okongwu *et al.*, 2008).

You may also use the `align` environment from `amsmath` package as shown in 2, which is the derivation of Q^* ,

$$\frac{dTC}{dQ} = \frac{d}{dQ} \left(\frac{DS}{Q} + \frac{QH}{2} \right) \quad (2)$$

$$= -\frac{DS}{Q^2} + \frac{H}{2} = 0 \quad (3)$$

$$Q^* = \sqrt{\frac{2DS}{H}}. \quad (4)$$

Here, TC is the total cost, consisting of ordering cost and holding cost

$$TC = \frac{DS}{Q} + \frac{QH}{2}. \quad (5)$$

Note that all equations must be numbered. Avoid using `equation*` environment.

Tables should present useful information and not merely duplicating what is in the text. Tables should be numbered. The caption should be clear enough to represent what is presented in the table. Please supply editable files (for example, tables should not be put in the form of a picture).

All figures (see, e.g., Figure 1) and tables should have clear captions and inserted directly in the body of the paper (NOT listed in the back of the paper).

The use of footnotes and endnotes should be avoided.

Submission of the revised manuscript should be accompanied by a few pages outlining how each comment from the reviewers have been addressed. The revised paper should show the modified or revised parts, by for example, marking these new or revised parts with a different font color.

For journals: Last name, initials (year), article title. Journal Name (*italic*), volume, number, page numbers. For example: Wang, X., and Liu, L. (2007). Coordination in a retailer-led supply chain through option contract. *International Journal of Production Economics* 110 (1-2), pp. 115 – 127.

For Conference Proceedings: Last name, initials (year), article title. *Conference Name (Italic)*, Conference Location, page numbers.

For sources from the Internet: Add the URL address and date of access after any possible information such as authors' name, title of the article, etc.

ACKNOWLEDGEMENTS

(Write the acknowledgements here). Acknowledgement, if any, should be placed before the list of references. When the paper is written as part of a funded research, please acknowledge the source of funding.
